-Vice-President Benakovich started our regular meeting @ 6:12 pm & led everyone in the Pledge of Allegiance followed by a moment-of-silence.

-MINUTES, PAYROLL, BILLS & CLAIMS:

VISITORS: JENILYNNE HALL, WHITE COUNTY AREA PLAN DIRECTOR...Jenilynne presented Amendment to Zoning Ordinance #A72. Amendment A72 is a proposal to establish regulations and standards for carbon sequestration projects. This amendment addresses areas such as facility locations, infrastructure development, carbon storage and pipeline transmission, application requirements, pre-application and application agreement requirements pertaining to roads, road maintenance, drainage, decommissioning and economic development.

Ken Hickman made a motion to approve Amendment A72.

ALICIA HUFFORD, HOWE INSURANCE AND JULIE SARTORI, GUTWEIN RISNER

INSURANCE...Both companies presented their bids for the Town of Monon package and worker's comp insurance. The board members will review the proposals submitted.

The cost would be \$1,070.42 for JK Communications. 5. Roger would like to stop brush and leaf pickup for the winter. The board members were in agreement with this. They will pick up anything that is currently out there and then stop for the winter. 6.Roger stated he was contacted by Vanguard regarding a solar company that wants to put solar fields near the old Hedges property south of town. They contacted Vanguard for an easement, but Vanguard does not want to grant the easement if it will negatively affect the town.
